WHY WILLS MATTER

Nobody wants to think about dying, but it's important you take care of your loved ones.

THE BENEFITS OF YOUR WILL

A professionally drafted will makes sure that your wishes are clearly understood and specifies who you want to appoint to make sure that they are adhered to. This person or persons is/are your Executors and can be family members, friends or, quite often, the firm of solicitors that helped you with your will. The choice is yours and like everything else in your will, it can be changed at a future date.

WHERE DO I START?

Most wills are easy to make; you just need to see a Solicitor or another suitably qualified professional. Tell them what you want to put in your will and sign it once you're happy with the contents. It helps to have thought about things before you go to your appointment. Your will must be drawn up and witnessed properly for it to be legal and effective.

Cost can vary depending on how complicated your will is.
